Mini Mahi Tournament

- This is a boat tournament. Entry fee is \$200 for all boats.
- Registration is open online only. Boat representative will initial when registering that they understand and agree to the rules. There will not be a captains meeting.
- Optional Calcuttas are as follows:
 - Single Fish - \$100
 - 2-Fish Aggregate - \$100
- The tournament will run from 7am - 4pm on Saturday, May 6th. Rain day is Sunday, May 7th.
- This is a SINGLE FISH - WINNER TAKES ALL tournament. Boats may weigh as many fish as they have anglers.
- Prizes awarded to top Lady and Jr Angler.
- In case of a tie, the winner will be determined by who met winning weight first.
- All fish must be brought to the weigh station at NEFMA Clubhouse by 7pm.
- All fish must be caught on rod and reel, using traditional Mahi fishing methods.
- Official weight will be based on the whole fish weight. The Tournament Weigh Master, Director or Tournament Committee reserves the right to reject any fish entry because of poor condition or mutilation. Any fish deemed irregular or questionable will be grounds for disqualification of that entry. All decisions are final.
- Angler or Boat Representative must finalize entry weight with signature directly after announcement of weight.
- Anglers/captains are responsible for following all Federal, State, and local fishing and boating laws. Any boat receiving a citation from a law enforcement agency, while fishing for tournament, will be disqualified from the tournament. All anglers on the boat must have a valid Florida fishing license.
- Eligible fish are: Mahi Mahi
- All fish must meet current FL state size requirements. All fish must be caught on rod and reel from a boat.
- One prize per angler. Calcutta prize not included.
- Entrants/Anglers assume all risk involved with the tournament. Anglers enter the tournament at their own risk. Northeast Florida Marlin

Association, its officials, committee members or sponsors shall not be liable for and hereby disclaim any liability for any and all losses, damages or injuries of any kind suffered by any participants, entrants, anglers, their guests and companions, boat captains, vessels, and equipment which may occur during the tournament.

- Any protest must be made in writing and be accompanied by a \$100 cash deposit. If protest is upheld, the deposit will be refunded. If the protest proves invalid, the deposit will be forfeited.
- Decision of the tournament committee is final. Violation of tournament rules will subject the angler to disqualification. In the event of disqualification, tournament entry fees will be forfeited.
- Any or all prize winners and contestants may be subject to polygraph test. In the case of a failed polygraph test, participants will be disqualified from the tournament.
- All rules are subject to change and will be announced prior to 7am on day of tournament.
- No refund of entry fees, unless the Tournament Committee cancels the Tournament.
