- The NEFMA Mahi Mania Tournament will run from Friday, April, 5th, 2025 through Sunday, June 8, 2025.
- Each boat will be eligible to fish a maximum of 3 days. The Captain must declare using the NEFMA app no later than 8:00 pm the day before the desired fishing day.
- The heaviest 3 fish aggregate will be the 2025 Mahi Mania Tournament Winner.
- Each boat will be eligible to weigh up to 3 Mahi per day. If more than 3 fish are weighed throughout the tournament, the smaller weights will be dropped.
- You may leave and return from any inlet of your choice but may not deploy baits outside of the boundaries.
- All fish must be weighed at Beamish Custom Tackle by 5:30 pm the day of fishing or between 9:00 am and 2:00 pm the next day and Sunday, between 9:00 am and 12:00 pm. No mutilated fish will be accepted.
- This is a NO CHECKOUT TOURNAMENT. Lines in day declared at 6:00 am till 5:00 pm. You must return to the inlet of your choice by 8:00 pm on your designated fishing day on your own power. You may leave the inlet as of 12:01 am of the declared day.
- The Captain and crew of all entrants are subject to a
  polygraph at any time during the tournament. Winning
  Captains WILL be required to submit and pass a polygraph
  test prior to being presented any prize. Failure to submit to a
  polygraph test automatically revokes all claims to prizes and
  disqualifies the Captain and crew from the tournament. All
  team members must possess a valid Florida fishing license.
- A maximum of 8 lines are allowed. No electric reels permitted for trolling any hooked bait or lure. Electric reels may be used for hookless teasers. Wire Lines are allowed. A digital photograph of the fish with the tournament issued boat number is required on the water after the fish has been landed.
- The winner of the NEFMA Mahi Mania Tournament does not have to weigh 3 fish. If a boat's 2 fish are heavier than another boat's 3 then the boat with the most weight will be declared the winner. In the event of identical weights for any aggregate category, the tie will be broken on the team's largest fish of those weighed in. In the category of largest fish, the tie will be broken upon earliest weighed fish.

- You may undeclare a fishing day for whatever reason by 8:00 am through the app on the declared fishing day or by texting (904) 669-5153.
- You may substitute a boat once if the substitute boat is not registered in the tournament.
- Use of flying drones during this tournament is allowed.
- Boats cannot win both Aggregate and Big Fish prizes.
- Boundary is latitude 30.48.000 North and 29.18.000 South.
- All boats must fish in the Atlantic Ocean in US waters.
- All decisions by tournament committee are final.
- All protests must be submitted in writing to the tournament committee with a \$500 deposit within 24 hours of when the score is posted. If the protest is upheld, the deposit will be returned.
- Entry Fee: \$500.00 until April 4th
- The Captains Meeting Kickoff Party will be Wednesday, April 4th, 2025 – starting at 5:00pm. Sign up will close at 6:30pm. Captains meeting will begin at 7:00pm at the NEFMA Clubhouse.
- All declared boats must check in via the app by 8:00 pm on their declared day of fishing and submit their on the water photo.
- Tournament reserves the right to refuse entry from any
- captain at its discretion.
- Only one entry per Captain is permitted.
- Junior Anglers must be ages 8-17 as of March 26, 2025.
   Proof of age may be required to claim a prize. The Jr anglers' fish may NOT be one of the fish used in the daily 3 fish aggregate being weighed in.
- Each boat must leave and return to land on its own power. If a
  boat needs assistance, it is encouraged for participants to
  render assistance. The boat receiving assistance will be
  disqualified for the day but the boat rendering assistance will
  be allowed to weigh and may be granted an extension at the
  discretion of the tournament director.
- To qualify for the lady angler division, angler must be at least 18 years of age. The Lady anglers' fish may be one of the fish used in the boats 3 fish aggregate. She must also be the angler on the rod for the complete fight until the fish is boated.
- Junior and Lady anglers must be registered as anglers in the app by 4/4/25.

#### **MAHI MANIA WEATHER**

This is a Captain's Choice tournament. Each captain is solely responsible for the safety of his or her vessel and crew at all times. Captains and crews are responsible for following any federal, state and local fishing or boating laws. We encourage all Captains to heed any weather warnings or dangerous weather conditions, as safety is paramount. It is up to each Participant to determine whether their craft is seaworthy for the conditions of any given fishing day.

#### **Small Craft Advisory**

A fishing day will automatically be cancelled for the next day if, at 9pm the evening before, the National Weather Service Marine forecast has a "Small Craft Advisory" in effect for winds of 20 knots or more for the next fishing day. "Small Craft Exercise Caution" is still Captains Choice and can be a fishing day. These forecast zones will be the Altamaha Sound to Flagler Beach, Flagler Beach to Volusia/Brevard County line and the Volusia to Sebastian Inlet 20-60 mile zone. The Inlet you depart from will be the NWS Zone that will be used to determine whether it is a fishing day or not. A fishing day will not be cancelled due to large swells.

TWT is cash only! You may enter for any of the TWT's the night of the Captains meeting before 6:30pm. Tuna, Wahoo, Marlin, Sailfish TWT pay one place per species WTA.

To qualify as a "Released" fish and receive points, a video of the fish with a time and date stamp must be submitted via the Reel Time App & must allow the tournament committee to identify the species of the fish and determine that the fish is "under control" of the crew and released. "Under control" means that the crew has leader in hand or it is clear that the wind on leader is on the rod. No picture, no date & time on the picture, no points.

Points for releases are considered awarded at the time of release. In the case of tied points for a releases, the boat that accumulates its points first is the winner, i.e., 2 Sailfish released on your 1st day will win over 2 Sailfish released. In the case of tied overall points for the grand prizes, the boat that accumulates its points first is the winner.

The Atlantic Highly Migratory Species (HMS) Permit Shop makes it easy to apply for and renew the following federal vessel permits required to fish for Atlantic tunas, billfish, swordfish, and sharks.


